RE: Review of AB 832 and SB 128

The attached survey results review the answers of members who responded to CAMFT's request for input on AB 832 and SB 128. Also attached is the text for each bill, as well as each bill's analysis.

AB 832 (Mandated Reporting):

Existing law provides parameters for when consensual intercourse involving a minor is a mandatory report. However, there is no such break down for consensual oral copulation or sodomy; legally these two acts are always a mandatory report if a minor is involved. This bill would codify consensual oral copulation and sodomy similarly to sexual intercourse. This bill is currently in the Assembly Public Health Committee.

SB 128 (End of Life):

This legislation mimics Oregon's "Death with Dignity" law (1994). SB 128 makes assisted death available to those 18 or older who are diagnosed with a terminal illness that is expected to result in death within six months, provided they are mentally capable of making healthcare decisions. This bill is currently in the Senate Judiciary Committee.

The California Medical Association has gone on record with concerns but has not yet filed formal opposition as they have in previous versions of this legislation. It is likely that the CMA will stay neutral.


As of April 17, 2015, 1453 members responded as follows:

Support: 877 members (60%) Oppose: 160 members (11%) Neutral: 356 members (25%) No Opinion: 60 members (4%)

It is highly recommended to take the time to read the open-ended responses from our members to get a better of sense as to the reasoning behind their chosen position given the extreme controversial nature of this bill.

Q1 SB 128, which is modeled after Oregon's Death with Dignity Act (1994), makes assisted death available to those 18 or older who are diagnosed with a terminal illness that is expected to result in death within six months, provided they are mentally capable of making healthcare decisions. The individual must be deemed mentally competent by a psychiatrist or psychologist licensed in California. Proponents of the legislation state that this legislation establishes a humane process that honors a terminally ill patient's right to make informed decisions about dying, including an individual's option to reduce suffering by taking aid-in-dying medication. Opposition comes from religious leaders who consider suicide immoral: from some medical groups, that believe that a doctor's job is to heal; and from advocates for the disabled. who say the sick could be coerced to end their lives to save medical costs or by heirs with other agendas. My recommendation for SB 128 is:





Q3 AB 832 is intended to create a uniform standard for mandated reporters to follow when reporting instances of consensual sexual acts amongst minors. Currently, sexual intercourse of minors is only reportable if it is coercive and/or involving minors of disparate ages; consensual sodomy and oral copulation between minors is always a mandatory report. Amended reporting requirements would categorize consensual sodomy and oral copulation the same as consensual intercourse amongst minors of nondisparate ages. It is likely this bill will receive opposition from some family or parent advocacy groups. However, given it is early in the legislative season, the extent of the proponents and opponents as well as the philosophies behind their positions are not yet known. My recommendation for AB 832 is:
